## **POSITIVE IMPACT OF MANDATED MEMBERSHIP**

- Clarity around player status and insurance
- Increased direct investment into local grassroots squash
- Enhanced value and support for players and clubs

- Financial burden reduced for clubs
- Streamlined processes easier resolution of issues



## **LEAGUE SQUASH:** CHALLENGES AND RISKS

- Communication and change management
- Different administration for clubs and leagues
- County rebates
- Different scheme more membership categories and prices
- New processes (direct data management)
- Potential participation impact (particularly in lower leagues)



# PROPOSAL: 'THREE STRIKE' RULE

- Membership among county league players rarely exceeds 75%\*
- Currently used in Avon to support infrequent league players and fulfilment of matches
- Would enable non-members to play up to three (TBC) matches each year before player 'fails' the membership check
- Technology implementation led by England Squash (minimal changes to league software)
