Terms and conditions

- The promoter is: England Squash whose registered office is at the National Squash Centre, Rowsley Street. Manchester. M11 3FF.
- The competition is open to residents of the United Kingdom aged 16 years and over. Those ages 16 - 17 will require their parents or guardians consent to enter the competition. Employees of England Squash and their close relatives and anyone closely connected with the organisation or judging of the competition are not able to enter.
- The competition will open on Monday 1st April 2019 and will close when 3,000 unique adult players have been recorded on the England Squash app.
- There is no entry fee and no purchase necessary to enter this competition.
- By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.

- The winner will be notified via email within 7 days of the target being achieved. The prize must be accepted within 7 days of the competition winner being notified. The right to the prize will lapse after this time.
