



ANTI-DOPING EDUCATION IMPLEMENTATION PLAN

(revised) JANUARY, 2021

Background

England Squash has a set of anti-doping rules that all athletes, coaches and athlete support personnel must abide by. The anti-doping rules for England Squash are consistent with the current World Anti-Doping Code which governs anti-doping internationally.

The anti-doping rules of England Squash are the UK Anti-Doping Rules published by UK Anti-Doping and are amended annually on January 1st. Such rules take effect and are construed as the rules of England Squash and the relevant athletes and personnel are informed. It should be noted that all anti-doping rules are applicable to all England Squash members regardless of an individual's participation level and athletes could be tested at major events in the UK or across the world (e.g., National Championships, British Open).

UKAD run an athlete Domestic Testing Pool (DTP). Athletes within testing pools must submit whereabouts information to UKAD and are subject to random testing (blood and urine). They must provide their whereabouts for 1hr each day, throughout the year. In addition, a specific 'major games' education programme is delivered by UKAD to selected athletes and staff during the Commonwealth Games cycle, and regular email updates are shared with all appropriate staff and players. At junior level, England Squash delivers in-house anti-doping education annually to our England Development (U19's) and England Academy players, via Lee Drew (National Junior Coach) and Josh Taylor (High Performance Coach), both of whom are trained UKAD Educators. Attendance records and email 'logs' are maintained.

The England Squash education programme is currently much less comprehensive at the lower end of our talent pathway and in the wider coaching and general community. Anti-doping rules are applicable to all England Squash members regardless of an individual's participation level and, whilst we're limited in terms of available resource (several NGB's have dedicated anti-doping roles), it is becoming more important that we consider how we're able to deliver key anti-doping messages and education to a wider audience. England Squash has been informed that the 2021 World Anti-Doping Code will outline a significant emphasis on the role of early (younger and lower down the talent pathway) education in preventing doping in sport and put an emphasis on the education of more players, coaches and associated personnel / support staff. It is a new area of focus for WADA and will require greater attention and resource from England Squash.

There is a need for a working group, with board representation to be formed. The group will need to ensure staff are adequately trained and supported and that a sport-wide strategy is implemented to educate the squash community about the dangers of anti-doping and the anti-doping code.

Consultation to Date

England Squash continues to work in partnership with UK Anti-Doping (UKAD) and the World Squash Federation to ensure the integrity of squash is protected.
